### BIOGRAPHY

As a federal prosecutor, Rob directed investigations into high-profile and sensitive matters. As a Commander (O-5) in the U.S. Navy Judge Advocate General's Corps, Rob is a Military Judge and has led legal teams as an Executive Officer, providing legal advice to military commanders both at home and deployed abroad. Rob also is a member of the Criminal Justice Act (CJA) panel in the Western District of New York and the Second Circuit, where he is appointed by the Court to represent indigent defendants in felony criminal trials and appeals.

Rob's experience in the courtroom before judges and juries, in the military and government before commanders, law enforcement officers, and bureaucrats, and in the private sector lends him insight on what matters to decision-makers. Working together in collaboration with clients and expert consultants, Rob aims to leverage the experience and knowledge of his clients, his litigation team, and himself to ward off litigation and, if necessary, to present a convincing case to defeat legal adversaries, no matter who they are.
